- Found the entity that you have searched against with the SRA who confirm that an entity practices as Broadway Solicitors with SRA number 301085.
- The SRA have informed us that the postcode you searched against relates to the head office and there are no conditions against this entity.
- The head office address is: First Floor, 40 Tooting High Street, London, SW17 0RG.
- The entity is Lexcel accredited.
- The SRA have informed us that there are no conditions or findings against solicitors listed as practising at the address you searched against.
- This is a sole practitioner, who was admitted on 31/02/2009 with SRA number 828 and has no conditions or findings listed.
- The Law Society have informed us that the firm is CQS accredited with number CQS01939. The firm was accredited on 10/09/2012 and the office searched is listed on the accreditation.
- We have found that the previous published year's data available from the Land Registry indicates a firm of the name Broadway Solicitors completed 27 transactions.
- The previous published month shows a firm of the name Broadway Solicitors completed 4 transactions.
- The sort code searched relates to HSBC UK BANK PLC, Tooting Broadway SW17 which is approximately 0.1 miles from the address.
- There does appear to be a firm website at http://www.broadwaysolicitors.com which confirms the address.
- Internet searches does show entries relating to the entity at the same address as given by the SRA.

- A search using streetview shows that the address appears to be office building on high street with the firm name permanently and prominently. Streetview image capture is dated May 2017.
- The entity appears to be a Limited Company, Broadway Solicitors LTD, with company number 10195890. The Registered Office is Broadway Solicitors, First Floor, 40 Tooting High Street, London, England, SW17 0RG which relates to the head office, and the company is listed as Active and incorporated on 24/05/2016. The company was dissolved on 10/07/2018.
- The entity does not appear to be listed on the FCA Register of Exempt Professional Firms.
- The entity does not appear to be listed on the ICO Data Protection Register.
- DMARC is an email protocol recommended by the Government's Cyber Security Centre. The
  domain <u>broadwaysolicitors.com</u> which appears to be associated with the firm you are searching
  against is not configured. This means that emails are relatively easy to hijack/impersonate for this
  firm and you should treat emails from them as not secure. Click here for further
